Wexford Hub Solar Farm Newsletter

The Wexford Hub Solar Farm is a new renewable energy project located in south Co. Wexford. It will be developed by Harmony Solar Dennistown Ltd, on behalf of ESB. See www.wexfordhub.ie for details on this project. The project will generate approximately 100MW of clean electricity; enough to power over 25,000 homes.

This project will consist of four separate sites of solar panels. Two of the sites are located at Dennistown and Mayglass, south of the village of Murntown.



The other two sites, Growtown and Youngstown are situated northeast and southeast of the village of Taghmon.

The sites will be connected to a new 110kV substation located at Dennistown, via two new 33kV (kilo volts) underground cables. A third underground cable will connect the new Dennistown substation to the existing Wexford 110kV substation at Barntown.

As part of this project, ESB is committed to engaging closely with the local community to ensure the successful delivery of the Wexford Hub Solar Farm by springtime 2027.

The project has secured planning permission for each of the four sites in recent years. Planning permission was also granted for the new 110kV Dennistown substation and associated cable route from Dennistown to the existing Wexford 110kV substation at Barntown. The 33kV cables have been granted Exempted Development status through three Section 5 applications. Details of each planning grant including dates and reference numbers are summarised in the table below.

The project successfully obtained a capacity contract in the RESS 3 (Renewable Electricity Support Scheme) auction in September 2023.



Construction Overview


Enabling works on the project have commenced in May 2025, at the Dennistown site. These works include construction of the access road and ground works for the new substation. Similar access road works will commence in Mayglass and Youngstown in July 2025.

Construction work on the Dennsitown substation will commence in July 2025.

Solar panel installation works are scheduled to commence in late 2025. These works will involve the mounting of solar panels on light steel frames, together with the installation of associated underground cabling.

The construction of the three underground cable routes for the project will also commence in late 2025. These works will consist of the installation of ducting, predominantly in public roads, prior to the installation of the electrical cables. In total there will be 30km of ducting across the three cable routes.

The first cable route will be from Growtown to Dennsitown, via Youngstown. The second route will be from Mayglass to Dennsitown, and the third route will be from Dennsitown to the existing 110kV substation at Barntown. Localised traffic management and road closures will be required to facilitate these underground cable works which will be agreed in advance with Wexford County Council.





Current Development Timeline

May 2025	Enabling works to provide access at Dennistown.
July 2025	Commencement of construction works for the Dennistown Substation and enabling works at Mayglass and Youngstown.
Q3 2025	Construction of the three underground cable routes due to commence.
Q4 2025	Solar farm construction works due to commence.
Q1 2027	Commissioning and project operational.

Traffic Management

Will there be traffic diversions and delays during construction?

Localised traffic management and road closures will be required to construct the new cable routes for the project. Diversions and delays will be minimised as much as possible. A Road Opening License for the underground cable works together with traffic management plans for each of the four sites will be agreed with Wexford County Council before each package of works commences. The project team will arrange updates and communications on this. Your patience in this regard is much appreciated. Once constructed and operational the only traffic to occur will be for occasional maintenance visits.

The impacts of such traffic will be negligible.





Solar components for delivery?

The solar panels and ancillary components are relatively small and are transported in pallets before being assembled on site. The pallets will be delivered in 40-foot containers that are transported by articulated lorries.

Where will access to the Solar Farm Sites be?

A detailed traffic management plan will be developed with Wexford County Council, for each of the four sites. The proposed access points are summarised as below:

Site	Access Point
Dennistown	On the L7098 road, approximately 500m east of the junction where the L7098 meets the L3041.
Mayglass	On the L3046 road, approximately 1.6km southeast of the junction where the L3041 road meets the L3046 road.
Youngstown	On the L70371 road north of where the L70371 meets the L70411 road.
Growtown	On the R738 approximately 2.9km west of where the R738 meets the N25.

The three cable routes will be constructed predominantly on the public road and a road opening license will be agreed with Wexford County Council for these works.





Community Benefit Fund

There will be a Community Benefit Fund associated with the Wexford Hub Solar Farm. Once the solar farm is operational, this fund will accept grant applications from organisations in the local area. The fund is intended to benefit the wider economic, environmental, social and cultural wellbeing of the local community.

ESB will enlist the services of SECAD, an independent administrator for Wind and Solar Farm Community Funds. This is their application portal website: www.communitybenefitfunds.ie. There is a Help Section on the site that communities may find helpful, including links to webinars etc.

While the solar fund is not operational yet, we encourage your local organisations to start thinking about the kind of projects you might submit and the supporting information SECAD will require.

Eagrán 1 - lúil 2025

Nuachtlitir Fheirm Ghréine Mhol Loch Garman

Tionscadal nua fuinnimh in-athnuaithe i ndeisceart Chontae Loch Garman is ea Feirm Ghréine Mhol Loch Garman. Is é Harmony Solar Dennistown Ltd a dhéanfaidh an tionscadal a forbairt thar ceann ESB.

Is ar www.wexfordhub.ie a gheofar na sonraí ar fad faoin tionscadal seo. Ginfidh an tionscadal thart ar 100MW de leictreachas glan; is leor sin le cumhacht a thabhairt do níos mó ná 25,000 teach.




Figure 1 - Site location map of Wexford Hub Solar Farm.

Beidh an tionscadal seo comhdhéanta de cheithre láithreán grianphainéal ar leith. Beidh dhá cheann de na láithreáin sin suite i mBaile an Dinigh agus i Maigh Ghlas, taobh ó dheas de shráidbhaille Bhaile Mhúráin. An dá láithreán eile, Baile Gró agus Baile an



tSiúnaigh, beidh siadsan suite soir ó thuaidh agus soir ó dheas ó shráidbhaile Theach Munna. Beidh na láithreáin nasctha le fostáisiún nua 110kV i mBaile an Dinigh trí dhá chábla nua 33kV (cileavolta) faoin talamh. Beidh cábla eile faoin talamh ann leis an bhfostáisiún nua i mBaile an Dinigh a nascadh leis an bhfostáisiún 110kV atá ann cheana féin i Loch Garman ag Baile an Bharúnaigh.

Mar chuid den tionscadal seo, caithfidh ESB dúthracht le caidreamh a bhunú leis an bpobal áitiúil d'fhonn a chinntí le go n-éireoidh linn Feirm Ghréine Mhol Loch Garman a chur i gcrích faoi earrach 2027.

Tá cead pleánala faighte ag an tionscadal le blianta beaga anuas le haghaidh gach ceann de na ceithre láithreán. Tugadh cead pleánala freisin le haghaidh an fhostáisiún nua 110kV i mBaile an Dinigh agus le haghaidh an chábla ghaolmhair ó Bhaile an Dinigh go dtí an fostáisiún 110kV atá ann cheana i Loch Garman ag Baile an Bharúnaigh. Ceadaíodh stádas Forbartha Díolmaithe do na cáblaí 33kV trí bhíthin trí iarratas a rinneadh faoi Alt 5. Tá achoimre ar gach cead pleánala, lena n-áirítear dátaí agus uimhreacha tagartha, sa tábla thíos.

D'éirigh leis an tionscadal conradh acmhainneachta a fháil i gceant faoi Scéim Tacaíochta Leictreachais In-athnuaithe 3 (RESS 3) i mí Mheán Fómhair 2023.



Forléargas Tógála

Cuireadh túis leis na hoibreacha cumasúcháin ar an tionscadal i mí na Bealtaine 2025 ag an láithreán i mBaile an Dinigh. Áirítear leis na hoibreacha sin tógáil an bhóthair rochtana agus na hoibreacha talún le haghaidh an fhostáisiún nua. Cuirfear túis le hoibreacha den sórt céanna ar an mbóthar rochtana i Maigh Ghlas agus i mBaile an tSiúnaigh i mí lúil 2025.

Cuirfear túis leis an obair thógála ar an bhfostáisiún i mBaile an Dinigh i mí lúil 2025.

Tá na hoibreacha suiteála grianphainéal le tosú amach in 2025. Beidh i gceist leis na hoibreacha sin grianphainéil a chur suas ar fhrámaí crualche tanaí, chomh maith leis na cáblaí gaolmhara faoin talamh a shuiteáil.

Cuirfear túis leis na hoibreacha tógála ar na trí bhealach cábla faoin talamh le haghaidh an tionscadail amach in 2025 freisin. Is éard a bheidh sna hoibreacha sin ná duchtáil a shuiteáil, i mbóithre poiblí go príomha, roimh na cáblaí leictreacha féin a shuiteáil. Beidh 30km san ionlán de dhuchtáil sna trí bhealach cábla.

Rachaidh an chéad bhealach cábla ó Bhaile Gró go dtí Baile an Dinigh, trí Bhaile an tSiúnaigh. Rachaidh an dara bealach ó Mhaigh Ghlas go dtí Baile an Dinigh, agus an tríú bealach ó Bhaile an Dinigh go dtí an fostáisiún 110kV atá ann cheana féin i mBaile an Bharúnaigh. Beidh gá le bainistíocht áitiúil tráchta agus dúnadh bóithre leis na hoibreacha cáblaí faoin talamh sin a éascú, rud a chomhaontófar roimh ré le Comhairle Contae Loch Garman.

Bainistíocht Tráchta

An gcuirfear trácht ar mhalairt slí agus an mbeidh moilleanna ann agus an tógáil ag dul ar aghaidh?

Beidh gá le bainistíocht áitiúil tráchta agus dúnadh bóithre leis na bealaí cábla nua a thógáil le haghaidh an tionscadail. Déanfar atreoruithe agus moilleanna a laghdú a oiread agus is féidir. Comhaontófar Ceadúnas Oscailte Bóithre i ndáil leis na hoibreacha cábla faoin talamh agus pleananna bainistíochta tráchta le haghaidh gach ceann de na ceithre láithreán le Comhairle Contae Loch Garman sula gcuirfear tús le gach pacáiste oibreacha. Tabharfaidh foireann an tionscadail tuairisci chun dáta ar na nithe sin. Táimid an-bhuioch díbh as foighne a léiriú ina leith seo.

Nuair a bheidh an fheirm tógtha agus ag obair, ní bheidh aon trácht ann seachas cuairteanna cothabhála ó am go chéile. Is beag difear a dhéanfaidh trácht den chineál sin.





Compháirteanna gréine a bheidh le seachadadh

Tá na grianphainéil féin agus na compháirteanna a bhaineann leo réasúnta beag. Úsáidtear pailléid le hiad a aistriú ó áit go háit agus curtuar le chéile ar an láthair iad. Déanfar na pailléid a sheachadadh i gcoimeádáin 40 troigh á n-iompar ag leoraithe altacha.

Cén áit a mbeidh na bealaí isteach chuig na Feirmeacha Gréine?

Déanfar plean mionsonraithe bainistíochta tráchta a ullmhú i gcomhar le Comhairle Contae Loch Garman maidir le gach ceann de na ceithre láithreán. Seo a leanas achoimre ar na bealaí isteach atá beartaithe:

Tógfar na trí bhealach cábla ar an mbóthar poiblí go príomha agus aontófar ceadúnas oscailte bóithre le Comhairle Contae Loch Garman le haghaidh na n-oibreacha seo.

Bunófar Ciste Sochair Pobail i dtaca le Feirm Ghréine Mhol Loch Garman. Nuair a bheidh an fheirm ghréine ag feidhmiú, tosóidh an ciste ag glacadh le hiarratais ar dheontais ó eagraíochtaí sa cheantar áitiúil. Tá an ciste beartaithe lena úsáid ar mhaithe le folláine eacnamaíoch, chomhshaoil, shóisialta agus chultúrtha phobal na háite.

Tá ESB chun leas a bhaint as seirbhísí SECAD chuige sin, is riarthóir neamhspleách a bhíonn ag plé le Cistí Pobail Feirmeacha Gaoithe agus Gréine.
